





### Comparative Rainfall: 2022 to 2024



### Comparative Rainfall: 2013 to 2024






### Rehabilitation

- HVO reached its rehabilitation target of 69ha during December 2024.
- An additional 88.5ha of previously rehabilitated land (GMD) was also seeded with final land use species in Carrington
- 55ha of rehabilitation and 11ha of GMD is planned for 2025
- Woop Dump remediation works complete








### **Biodiversity Offsets**

#### Activity focus:

- Environmental monitoring ahead of January reporting
- Management tasks to reduce fire risk ahead of summer (fuel reduction and firebreaks)
- Prickly Pear control at Mitchelhill

Monitoring for the Glencore Biodiversity Report Card commenced with the intention to provide a consistent monitoring program and performance assessment across biodiversity offset areas for all Glencore sites





### **Operational Weed Management**

#### Activity focus:

- Managing the increased vegetation growth within planted areas to prevent overshadowing planted tubestock.
- Reducing weed coverage and pig habitat within riparian areas (Hunter R and Wollombi Bk).
- Reduce weed proliferation within and adjacent to priority areas.
- Target weeds including castor oil, balloon vine, green cestrum, galenia and inkweed





### Feral Pest Management

#### 2024 Programme

- HVO rural licensee pig control programs are ongoing via bounty payments. 59 claimed to date for 2024
- HVO granted a 'licence' to control Kangaroo numbers with 350 kangaroos culled under this license. In addition, 243 kangaroos were commercially harvested

Synchronised baiting and trapping programmes co-ordinated with other sites and Hunter LLS.






#### 22 November – Post Blast Fume Event

- Blast fume ranked as Level 4B in accordance with the AEISG rating scale
- Fume dispersed within the HVO West Pit blast exclusion zone
- An investigation into the incident found loading delays, explosive product (ANFO) and rain were the likely causes for the fume event
- The event was reported to the Department of Planning Housing and Infrastructure (DPHI).
   No further follow up was requested
- No community complaints were received as a result of the blast



# 14 December – Jerrys Plains PM10 (24hr) exceedance:

- Jerrys Plains TEOM measured 50.5ug/m³ against a criteria of 50ug/m³ (HVO North)
- HVO contribution to monitored result was 6.3ug/m<sup>3</sup>
- Reported to DPHI. Notification to be sent to Jerrys Plains residents







# 6 January – Cheshunt East PM10 (24hr) exceedance:

- Cheshunt East HVAS measured 56.1 ug/m³ against a criteria of 50ug/m³
- HVO contribution to monitored result was 22.8ug/m<sup>3</sup>
- Reported to DPHI. Notification has been sent to affected residents



#### Dam 17N discharge incident:

- During June 2024 water (approx. 523kL) was inadvertently pumped out of Dam 17N pump station sump into Farrells Creek via a small diameter hose
- Upstream and downstream water quality samples determined that no actual or potential environmental harm was caused
- HVO was fined \$30,000 by the EPA for contravention of HRSTS condition E1.1 (unauthorised discharge of saline water) during December 2024
- This penalty was reported in print, television and social media
- HVO has implemented field signage, procedure updates as well as sump pump upgrades to prevent any potential re-occurrence




#### **Annual EPBC Compliance Report:**

- Reports submitted annually for EPBC approval 2016-7640 and Enforceable Undertaking
- Submitted to Commonwealth Government 31 January 2025 and uploaded to HVO website
- No non-compliances with Enforceable Undertaking
- Compliance status for 2016-7640 related to offset swap and conservation mechanism.



### **Exploration Works 2024**

- No surface exploration has been undertaken in ELs during 2025
- Surface exploration (2 x drill holes) planned within EL 5417 and EL 5606 for 2024 will now be undertaken this year
- No timeline has been set for 2025 works
- Should further exploration works be required in ELs, HVO will conduct consultation with impacted stakeholders


### **HVO Continuation Project**

#### **HVO Continuation Project**

- NSW Dept. of Planning, Housing and Infrastructure "Request for Information" (RFI) asked us to consider implications of avoiding coal mining from the area referred to as gas Domain 1
- HVO is currently considering the RFI including undertaking additional modelling and mine planning to provide this information
- · HVO North time extension modification commenced

#### **Federal Approval Update**

- The Project requires Federal EPBC Act Approval
- Revised EPBC Act referrals being prepared in consideration of the broader HVOCP
- Submission anticipated Q1 2025



#### **Time Extension Modification**

- Modification Report Submitted Nov 2024
- Public Exhibition 27 Nov to 10 Dec 2024
- 105 submissions received 78% were in support of the Modification
- Key themes in support:
  - Positive economic benefits of continuing mining and local economy
  - Need for reliable and affordable energy supply
  - Positive impact of HVO on local communities through direct employment and contributions to local services
- Key themes in objection:
  - · GHG emissions and the Modifications alignment with climate change targets
  - Ongoing air quality, surface water and groundwater impacts
  - The adequacy of the level of assessment
  - Consideration of cumulative impacts and closure planning
- Submissions Report submitted 24 Jan 2025
- Assessment and determination March 2025




